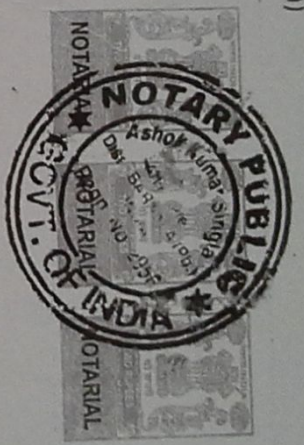



Sir,
With reference to above mentioned subject.

1. The required documents including affidavit, recommendations of District Education officer, Education Department (SS) and Director (Senior Secondary) Punjab Chandigarh have been considered thoroughly and the required No Objection Certificate is given on the following conditions:
In future in case of any complaint/inspection it is found that you have given wrong information during getting NOC from Punjab Government or you have not followed the instructions given from time to time by Punjab Government in this way conditions given in affidavit are not followed then in such condition this NOC can be withdrawn.
2. It is compulsory to teach Punjabi up to Matric level in your school CBSE New Delhi will make compulsory arrangements for conducting Punjabi examination. It is also mentioned that if this condition is not fulfilled NOC can be withdrawn.
3. The school management will follow RTE Act 2009 rules exactly made for Punjab State.
4. After getting affiliation from CBSE the school management is bound to pay the salary and other allowances to teaching and non teaching employees at par with Government employees by cheque if not followed NOC can be withdrawn.

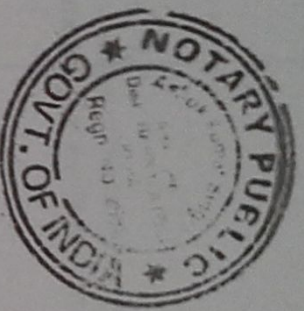
